WHEREAS in terms of Section 15 (1) of the NCTE Act, 1993 **BHUTTA COLLEGE OF EDUCATION ALAMGIR-RARA SAHIB ROAD VPO. BHUTTA, TEHSIL - DEHION LUDHIANA-141026, PUNJAB** had submitted an application (Code No. APN05021) to the Northern Regional Committee of National Council for Teacher Education for grant of recognition / permission for an additional intake of 100 in **BED** Course of 1 year duration.

2. AND WHEREAS on scrutiny of the application submitted by the institution, the documents attached therewith the Affidavit and the inputs received from the Visiting Team in the form of report and videography, the Committee is satisfied that the institution / society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the Secondary Teacher Education Education including the Norms and Standards for the Secondary Teacher Education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory etc for running the programme and has selected / appointed duly qualified teaching staff as per NCTE norms.
3. Now, therefore, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to **BHUTTA COLLEGE OF EDUCATION ALAMGIR-RARA SAHIB ROAD VPO. BHUTTA, TEHSIL - DEHION LUDHIANA-141026, PUNJAB** for an additional intake of 100 students in **BED** course of 1 year duration and thereby making the annual intake of 300 students under clause 7 (12) of NCTE Regulation dated 13th Jan 06 subject to fulfillment of the following :-
 - (i). The institution shall within one month of the receipt of recognition order, convert the Endowment Fund account into a Joint Account to be operated along with an official of the Regional Committee.
 - (ii). The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, as amended from time to time.
4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government, etc, wherever applicable.
